# PRESENTATION OF 2022 FPA SCHOLARSHIP AWARDS

At our upcoming General Membership Meeting scheduled for June 3, the Friends of Polish Art will award up to five Frank Filipek scholarships, each in the amount of \$2,500. The scholarships will be awarded to those pursuing academic studies in such areas including: law, medicine, architecture, engineering, sciences, and the liberal arts with the exception of the fine arts.

In addition, FPA will award up to two Mitchell Fine Art Scholarships, each in the amount of \$2,500. These scholarships will be presented to students pursuing studies in painting, sculpture, music, drama, theater, dance, and other forms of creative expression as well as history, literature, religion, philosophy, and Polish Studies.

Please make it a point to join us at the presentation and congratulate this year's scholarship recipients. A reception with cake and light refreshments will follow the presentation.

**Fourth,** the Board is planning to have the very popular Wigilia in mid-December. The planning is well underway. More information on this event will be provided in a future newsletter.


